CREDIT AGREEMENT

The above-named applicant (the "Company") for credit hereby authorizes QLogic to obtain such information as it may require concerning the statements in this application and agreement. The Company agrees that the above information is true and complete and is submitted for the purpose of obtaining credit.

QLogic may from time to time in its sole and absolute discretion extend credit to the Company, and in connection with any extension of credit to the Company by QLogic, the Company and QLogic agree as follows:

- The Company will pay when due, according to their terms, all invoices from QLogic at the address set forth on the front of this application.
- All past due balances will bear interest at the highest rate permitted by applicable law
- The Company will pay any costs of collection related to past due balances, including attorney's fees and costs related to any litigation or collection efforts.
- QLogic may at any time, in its sole discretion, cease to extend credit to the Company.
- This agreement is governed by the laws of the State of California and any action to enforce this agreement may be brought in Orange County, California.
- The terms of this agreement shall govern the extension of credit to the Company unless and until the parties subsequent to the date of this agreement execute and deliver a subsequent written agreement with different terms and conditions.

RESALE/EXEMPTION CERTIFICATE
